

REQUEST FOR 2009 FRM® EXAM ALTERNATIVE DATE FOR RELIGIOUS REASONS

DEADLINE FOR SUBMISSION: AUGUST 31, 2009

A candidate whose religion prevents him or her from taking the Financial Risk Manager (FRM) Examination on the scheduled date (November 21, 2009) may request to take the examination on the alternate examination date (November 22, 2009). A "religion" is a moral or ethical belief as to what is right and wrong which is sincerely held with the strength of traditional religious views.

To complete the form you must:

- Enroll and register for the FRM examination, no later than August 31, 2009.
- Complete Section I – Candidate Information.
- Give this form to your religious leader or another individual who can verify your sincerely held belief that you are restricted from taking the test on the scheduled date. Please have them complete the verification in Section II.
